# 2018 Management Elk Hunt

#### PLEASE READ CAREFULLY SO YOU FULLY UNDERSTAND THE PROCESS

- ➤ There will be 30 hunts this year, 5 BULLS, 15 COWS & 10 Spike TAGS
- Applications are available through the CRST GFP office or website www.crstgfp.com
- ➤ There is a \$20 NON-REFUNDABLE application fee per choice.
- ➤ Application fee must accompany application to be entered.
- Applications can be submitted starting June 4 through August 31, 2018.
- ➤ Deadline for applications is August 31, 2018.
- > Drawings will be held on September 7, 2018 via computer generated drawing.
- ➤ Successful applicants will be notified by phone on September 7, 2018.
- ➤ Hunts can be scheduled between October 15, 2018 November 2, 2018.
- ➤ Elk hunts will be conducted between October 15 and November 2, 2018. (NO EXCEPTIONS)
- > You may enter for more than one hunt however, a separate app fee will need to be included for each hunt
- ➤ There will be 3 computer drawings
  - 1<sup>st</sup>----Bulls
  - 2<sup>nd</sup>---Cows
  - 3<sup>rd</sup>---Spikes
- > If you are entered in both drawings you will get the tag for whichever is drawn first
  - For example: if your name is in each drawing (bull, cow, and spike) and you do
    not draw a bull first, your name will still be in the next drawing. Therefore, if you
    draw a bull tag, then your name is removed from the next drawing. YOU CAN
    ONLY HAVE ONE TAG!

# **Guidelines:**

- ➤ All hunts will be **MANAGEMENT HUNTS.**
- ➤ 1-day hunt guided by GFP personnel.
- Morning hunts will begin at 9am and evening hunts will begin at 1pm.
- > CRST GFP will decide which bull will be harvested: Restricted to 5-Points or less.
- ➤ All hunts are located within the reserve on the Cheyenne River Sioux Reservation.
- > The CRST GFP personnel will assist in the field dressing of the animal.
- ➤ No lodging or meals will be provided.
- > No transportation will be offered.
- ➤ The hunter is responsible for game processing & taxidermy fees.
- Legal weapon: .30 cal. or greater. No rimfire. No archery.
- > GFP will provide transportation to hunt area and the transport of animal out of the Elk reserve. Exceptions will be made for handicapped hunters.
- ➤ Only the hunter and 1 guest will be allowed in the reserve during the hunt. Guest may not carry a firearm.
- > Guides can intervene if they deem necessary.
- ➤ NO transferring of tags.
- ➤ Individuals must be 15-years-old or older and all hunters under the age of 18 must possess a hunter's safety certificate to be eligible for a hunting license. (MUST BE 15 YEARS OF AGE AT TIME OF HUNT)
- > CRST GFP IS NOT RESPONSIBLE FOR ANY ACCIDENTS AND A LIABILITY WAIVER WILL BE REQUIRED FOR EACH HUNT.
