Possession Limits: No More Than Twice the Daily Limit

ENROLLED TRIBAL MEMBERS: Individuals who are enrolled in the Cheyenne River Sioux Tribe, regardless of residence. Proof of enrollment will be <u>required</u> for those individuals who are not on the enrolled member listing compiled by Game, Fish, & Parks over the years.

- ENROLLMENT VERIFICATION CAN BE OBTAINED AT THE ENROLLMENT OFFICE, WHICH IS LOCATED IN THE BIA REALTY OFFICE.

ELDERLY: Enrolled Tribal Members who are 60 years old and older.

<u>NON-MEMBER INDIAN SPOUSE:</u> Individuals who are enrolled in another federally recognized tribe and are married to an enrolled member of C.R.S.T. <u>PROOF OF ENROLLMENT MUST BE PRESENTED PRIOR</u> TO RECEIVING A LICENSE AT MEMBER PRICES -

<u>**YOUTH</u>**: Ages 12 - 15 years old. No fee required, except for Big Game and Spring/Fall Turkey season. Must be accompanied by a licensed adult.</u>

HANDICAP: Any licensed hunter who is unable to step from a motorized vehicle without crutches or a wheelchair. A physician's medical certificate or letter signed by the applicant's treating physician indicating the applicant's disability may be required of applicants for handicapped hunter's permit prior to the issuance of such license. Must be an enrolled Cheyenne River Sioux Tribal member to receive free handicap licenses.

INCOME ELIGIBLE: Tribal members must bring in proof of low income, as defined by any federally funded, needs-based program. <u>Must</u> be presented prior to receiving a hunting license free. **NONMEMBER/NONRESIDENT**: Are individuals who are not enrolled in the Cheyenne River Sioux Tribe.

** * NOTICE ***

Non-tribal members <u>must</u> obtain a tribal license and the lessee's permission, prior to hunting or fishing on any tribal land. Be sure to close all gates when you have entered or are leaving a tribal range unit.

HUNTER ORANGE

Shall be worn by hunters above the waist in the field when hunting any wildlife (except Waterfowl and Spring Turkey), and shall consist of no less than a bright orange hat or vest.

LITTER LAW

A litter law is in effect. Please pick up your trash after leaving each range unit you are hunting or fishing at. Violators will be fined.

FIRE HAZARD WARNING

- AVOID USING VEHICLES WHEN POSSIBLE, WALK IT'S WHAT HUNTING IS ALL ABOUT.
- Check with all range unit operators before driving around or through the range units.
- Absolutely no open campfires will be allowed.
- Avoid driving through tall grassy areas.
- Do not let vehicle idle for prolonged periods of time.

* * IMPORTANT NOTICE * *

Any tribal member, who picks up another tribal member's license, with their written authorization, are required to fill out their license and sign for it. Any individual, who performs misrepresentation in the form of not obtaining written authorization, is in violation of the CRST Hunting & Fishing Code. Violators will be dealt with appropriately.
